

Hanover Township Butler County, Ohio

Board of Township Trustees Special Meeting November 13, 2025

Call to Order: Jeff Buddo, Presiding. Mr. Buddo called the meeting to order.

Roll Call: Township Fiscal Officer/Clerk- Gregory L. Sullivan. Present Trustees Buddo, Miller and Johnson, Township Administrator Mr. Henry.

Purpose of the meeting: Discuss personnel issues and review legal opinion in accordance with Ohio Revised Code 121.22

The public portion of the Board meeting was convened. After a brief discussion about the Fire Levy, Mr. Johnson made a motion to move into Executive Session to Discuss personnel issues and review legal opinion in accordance with Ohio Revised Code 121.22 which was seconded by Mr. Miller. Mr. Sullivan called the roll with all three Trustees voting yes.

After a period of time, Mr. Johnson made a motion to move out of Executive Session and reconvene to the public session which was seconded by Mr. Miller. Mr. Sullivan called the roll with all three Trustees voting yes.

Mr. Henry discussed the Community Development Block Grant applications submitted by the Township. Concerns were expressed about the movement to discontinue the property tax base in the state and the possible impacts upon the Township. Mr. Henry expressed concern that perhaps only one project should continue on in the review process. He stated he wanted to withdraw the neighborhood clean up and curb repair for Alamo Heights and pursue the basic grant to repair and pave a portion of Amarillo Drive. The Board concurred.

To recognize certain individuals and to finish last minute housekeeping matters, Mr. Henry recommended having a Board of Trustees meeting on Wednesday December 3rd at 6:00PM. Mr. Buddo made a motion to set a Board meeting for December 3rd at 6:00PM which was seconded by Mr. Miller. After further discussion, Mr. Sullivan called the roll with all three Trustees voting yes. Mr. henry indicated the Records Commission could meet at 5:45PM.

There being no further public business for the Board to take up, Mr. Buddo **moved** to adjourn the Special Board meeting of November 13, 2025 which was seconded by Mr. Miller. Mr. Sullivan called the roll with Trustees Miller, Johnson and Buddo voting yes with the meeting ending at 11:24AM.
